Lessons learned - "Access to Digital Collections of Cultural and Scientific Content"

Those preparing proposals for the Action Line that is open now (ALIII.1.4) would be well advised to look carefully at the type and nature of the projects selected for funding after the first call (<http://www.cordis.lu/ist/ka3/digicult/en/projects.html>). It is not our intention to develop additional background material for the action line, however we can offer some important lessons learned from the first and second calls. Given the number of rejected proposals it is important to identify features that have not been successful to date, namely:

- Many proposals talked about access but were in fact focussing on routine digitisation processes.
Remember → proposals must have a clear research objective.
- Some proposals clearly targeted technology development of a specific nature or component, but did not firmly integrate that development within a specific well defined type of cultural content.
Remember → stress new alliances between technologists and heritage organisation, and be explicit concerning the actual cultural content being used.
- Many proposals were just for building web sites or portals.
Remember → this is a research programme and the first criteria is innovation.
- Some proposers clearly owned valuable cultural material but had little or no understanding of the technical and research issues.
Remember → focus on the research problem and describe carefully as well the cultural content in which the research will be performed.
- Some proposals provided precise statements of the problem, but were not able to describe a convincing research and development methodology.
Remember → we do research with a purpose and must see clearly what the results of the project might be.
- Some proposals were quite convincing on the problem and approach but failed to highlight clearly where the innovation was situated.
Remember → clearly describe the state-of-the-art, reference other works and explicitly describe where the innovative aspects are in the proposal.

Finally many proposers do not read, understand and apply what is written in the different documents: Fifth Framework Programme, IST Programme, Workprogramme 2000, and moreover the specific call documentation. Generally, final quality control of proposals is often poor with figures not adding up, sections missing or information repeated in several parts of the proposal.

Success stories

The TAP **LIBERATOR** project (Libraries in European Regions - Access to Telematics and other resources) established four regional information services in Europe: Alentejo (Portugal), Aquitaine (France), the North of England (UK) and Vlaams Brabant (Belgium). Collectively they reach over 8 million citizens through over 300 public libraries. Supported by the Royal Danish Library School, the project has been achieved by public library partners sharing best practice and adapting service models to suit diverse cultural circumstances. CECUP, the Central and Eastern European Copyright User Platform, aimed at helping to create awareness of the key issues around the copyright of electronic materials among librarians in Central and Eastern Europe. To achieve this, 10 workshops were organised with over 720 participants, a web page was maintained, discussions with rights owners took place and a state-of-the-art report on the copyright situation in C&EE (<http://www.eblida.org/cecup/docs/frdocs.htm>) was prepared. A very timely project, it ran during the period when most of these countries were revising their copyright laws and it succeeded in creating copyright working groups of librarians to further discuss the issue in most of the countries and to include librarians in the discussions on the new copyright laws with the law revisers in at least 5 of them. <http://www.eblida.org/cecup/index.htm>

CULTURE 2000 is an European Union financial support programme aimed at European cultural co-operation. Its objectives are the promotion of cultural dialogue, creativity and the trans-national distribution of culture, the promotion of cultural diversity and common cultural heritage, and improving public access to culture – amongst other things. Calls for Proposals are launched at the beginning of each year. The programme started in 2000 and will run until 2004 inclusive. The first call was launched on 8 April 2000.

BRAVA - Broadcast Restoration of Archives through Video Analysis

The main objectives of the BRAVA project are to significantly enhance the efficiency of film and video-originated archive restoration process and to prepare the restored material for dissemination via multi-resolution digital video broadcasting standards. The efficiency of video programme restoration process will be enhanced through exploiting information obtained from a high-level video analysis tool to control directly an automated restoration system in real-time and by providing simple instructions in real-time which the user can understand and edit if necessary.
